The Federated Indians of Graton Rancheria Tribal Council has established the UC Scholarship (the "Scholarship"). The Scholarship covers tuition and fees, and professional degree supplemental tuition, depending on availability of funds, for UC students who are California Native Americans but not members of a federally recognized tribe. The Scholarship complements the UC Native American Opportunity Plan ("UC NAOP"), which provides a similar scholarship for UC students who are members of federally recognized Indian tribes.
