**Position Purpose:** The Federated Indians of Graton Rancheria's Tribal TANF Program of Sonoma and Marin Counties serves Native American families that are in need with temporary cash assistance and supportive services. Under the direct supervision of the TANF Program Manager, the Summer Youth Worker II provides direct service to youth and at-risk youth participants with an additional responsibility to assist program coordinators with planning programs and services. Outstanding candidates will be passionate about youth development, possess special skills or interests that they are enthusiastic to share, such as artistic or athletic abilities, math comprehension, or have experience working with children of all ages. Summer Youth Worker II will assist in the implementation of all department programs and services and collaborate with other community-based programs.

### **Minimum Mandatory Qualifications**

#### Experience:

- Four (4) years progressive field experience working with youth or at-risk youth, OR equivalent combination of education and formal work.

#### Education:

- Bachelor's degree in child development (or related field) or working towards degree in Child Development (or related field).

#### License/Certification:

- Must possess a valid driver's license and be insurable under the Tribe's policy.

#### Preferred Qualifications:

- CPR and First Aid Certifications.

#### **Background and Pre-employment testing:**

Must successfully clear pre-employment testing, including, but not limited to a criminal background check, fingerprinting, TB test and drug and alcohol screening.

#### **FIGR CITIZENS AND INDIAN PREFERENCE WILL APPLY**

The Federated Indians of Graton Rancheria is a federally recognized Indian tribe, and, pursuant to its Indian Preference Statute, gives preference in hiring in the following order of priority: (1) Citizens of the Federated Indians of Graton Rancheria, (2) Native Americans who are members of or affiliated with a California Indian Tribe with ties to Marin and Sonoma Counties, (3) Native Americans who are members of or affiliated with any other California Indian Tribe, and (4) other Native Americans who are members of a Federally Recognized Indian Tribe.

Applicants asserting American Indian preference must submit verifying information, such as written confirmation of tribal membership, Certificate of Degree of Indian Blood, or other documentary evidence.
